Apologies for the delay getting back to you about this.

We've received over 660 Expressions of Interest to the Regeneration Fund, with 66 of those taking the opportunity to submit their full proposals before the Round One Evaluation cut-off of 7 September.

We are continuing conversations with others who are working towards submitting their full proposals for one of the later evaluation rounds. During these conversations we're discussing each proposal and the strength of its fit with the fund. If the contribution to the fund outcomes is not particularly strong, then we're suggesting that applicants may withdraw their application prior to progressing to a full proposal. We don't want people to commit significant amounts of time developing their proposal when it isn't the right fit for the fund.
