Submission of Toilet Block drawings and specifications for National War Memorial (Pukeahu)

Dear Geoff,

Memorial Park Alliance (MPA) are seeking certification of the attached documentation which relates to the inclusion of a toilet block. The inclusion of a toilet block into the Park scope of works has been approved by the Ministry for Culture and Heritage and will be located immediately west of the Tangata Whenua Gardens (western).

This letter should be included as an addendum to the original documentation submitted to Wellington City Council (WCC) on 10 January 2014, and subsequently certified by WCC dated 3 March 2014.

As required under Part 2 (Conditions 3 to 7) of the National War Memorial Park (Pukeahu) Empowering Act 2012 (the Act), the MPA provide the following documentation to WCC for certification under section 24 of the Act.
