## Tēnā koe 9(2)(a)

I refer to your request received on 7 November 2022 which has been considered under the Official Information Act 1982 (OIA), for the following information:

From the inception of the Arts and Culture COVID Recovery Programme until November 2022:

- 1. How many of the funding recipients listed on the Manatū Taonga website were from Wairarapa? For the purposes of this OIA, this includes Masterton/Carterton/South Wairarapa.
- 2. If none of the successful applicants were from Wairarapa, how many applicants (per fund) were based in the Wairarapa?

Since the inception of the Arts and Culture COVID Recovery Programme until 23 November 2022, there was a total of ten funded recipients from the Wairarapa. This is summarised in the table below. Where the list of funding recipients has been published, the names of the recipients have been included.

Of the Arts and Culture COVID Recovery Programme funding recipients, the following were based in Wairarapa:
